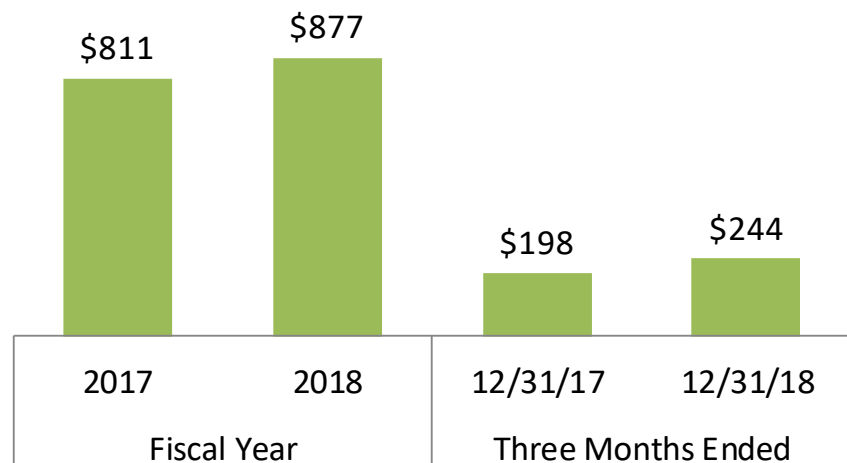

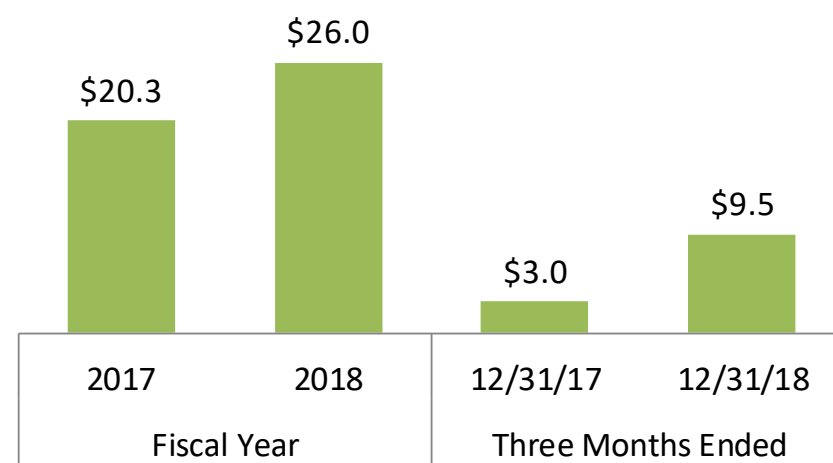

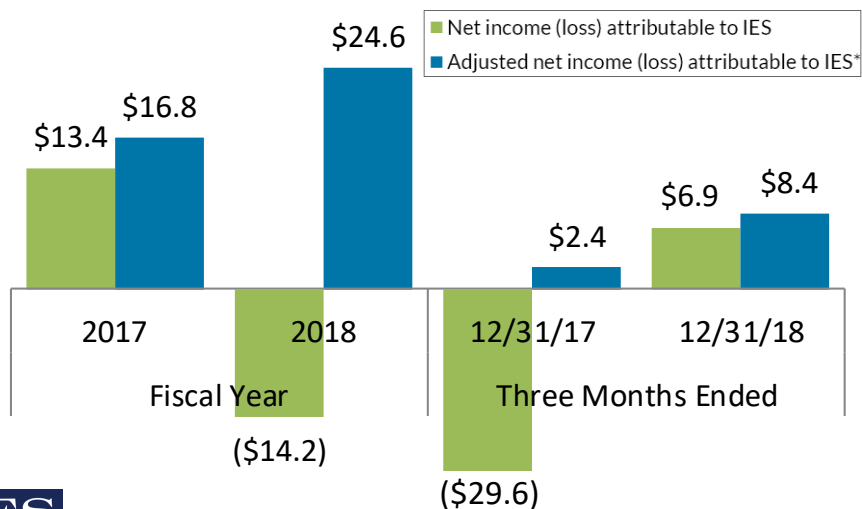
REVENUE



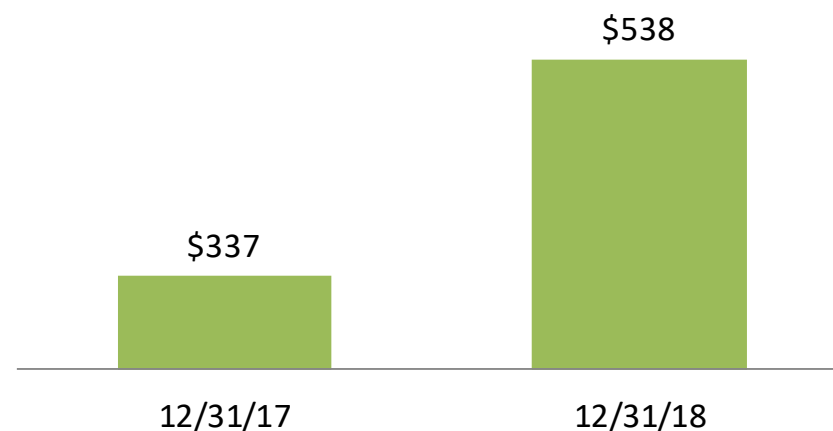
OPERATING INCOME

First Quarter 2019 Highlights

◆ Revenue

- \$243.8 million, an increase of 23% compared to \$198.3 million in the first quarter of FY18 (“1Q18”)

◆ Operating Income

- \$9.5 million, an increase of 217% compared to \$3.0 million in 1Q18

◆ Earnings

- Net income attributable to IES of \$6.9 million, or \$0.32 per diluted share, compared to net loss of \$29.6 million, or \$1.39 per diluted share, for 1Q18
- Adjusted net income attributable to IES (a non-GAAP financial measure; see supplemental disclosure table) of \$8.4 million, or \$0.40 per diluted share, compared to \$2.4 million, or \$0.11 per diluted share, for 1Q18

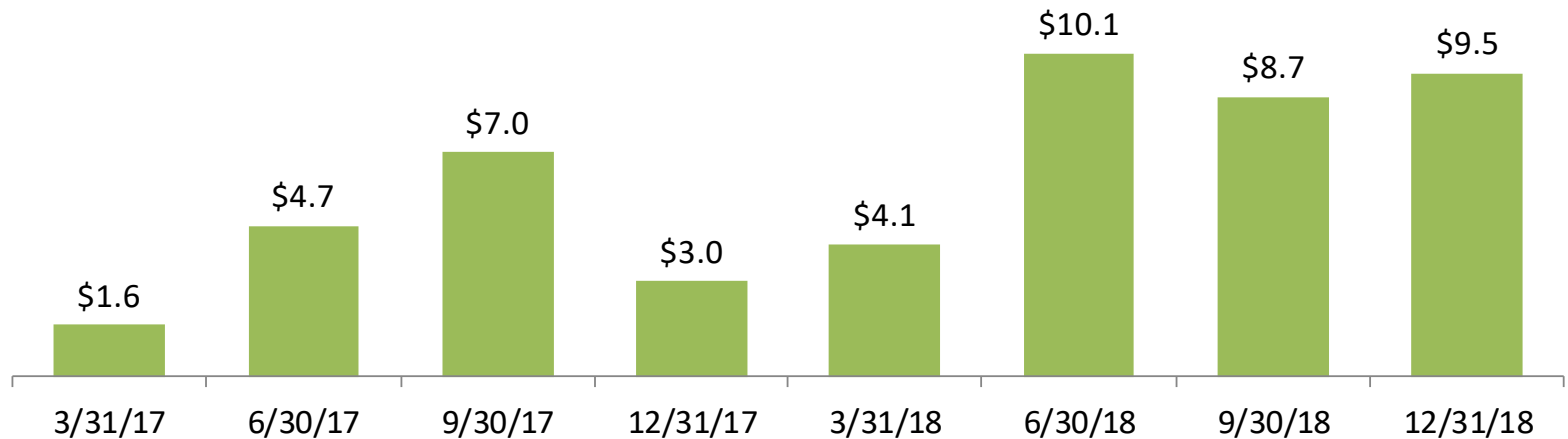

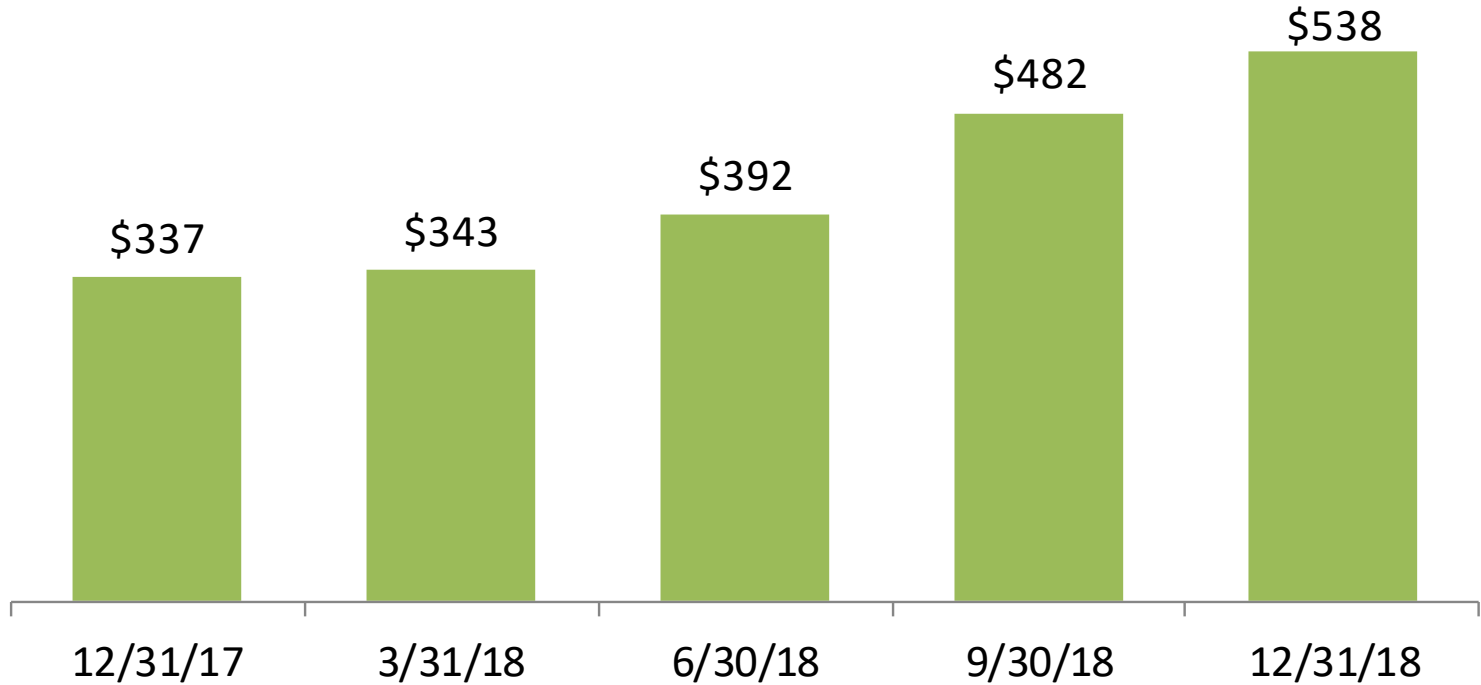


Operating Income

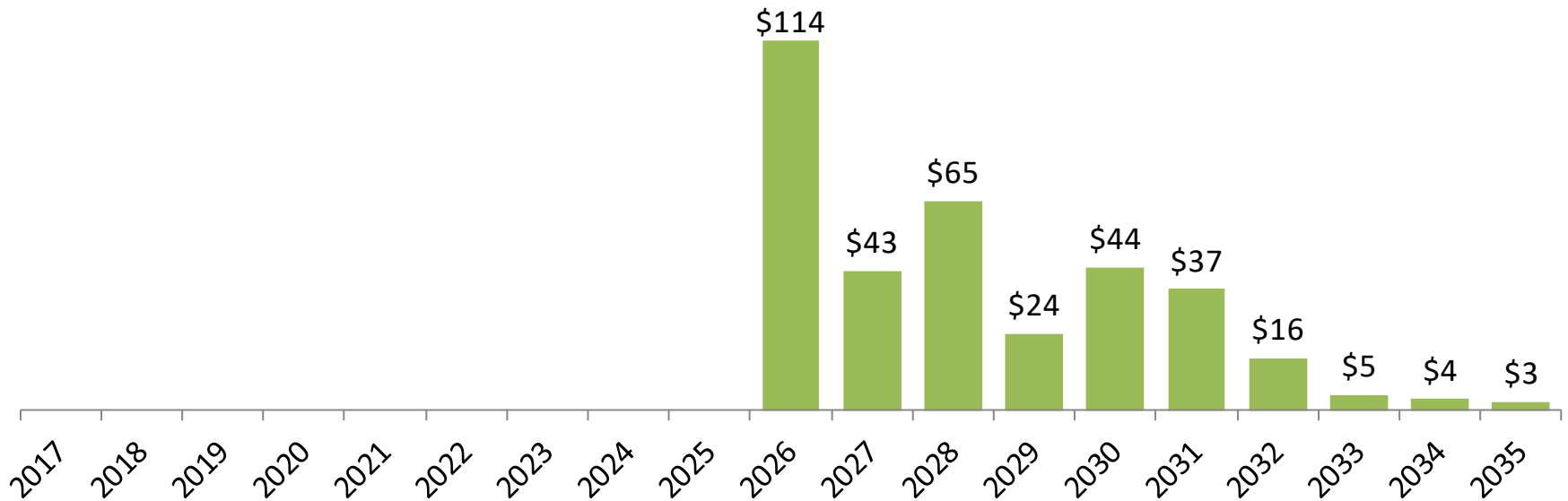

- ◆ Rights Agreement implemented to deter new 5% shareholders in order to prevent certain limitations on NOLs
